urges the Board of Directors to reconsider the staffing curtailments approved at the May 13, 2020 meeting. The furlough of such a large amount of staff is a great disservice to all students of the Ambridge School District, as class sizes will increase significantly, especially in primary grades where a foundational education of basic skills is of utmost importance. Classes of approximately 25 students in the incoming Economy first grade class is inconceivable.

Small class sizes ensure the following:

- -More one-on-one time
- -Easier to identify issues
- -More cohesive classroom culture
- -Teachers and students can form stronger, more personalized relationships
- -Students are more engaged
- -Less chaos, less clerical tasks

Research suggests long-term performance benefits and teacher retention when class sizes are smaller. I would be happy to elaborate on the advantages of small class sizes at your request.

All of the above would be true in normal times. However, when considering the information released by the Department of Education last week (Preliminary Guidance for Phased Reopening of Pre-K to 12 Schools: June 3, 2020; Version 1), the suggested class sizes are, at best, negligent to the safety and welfare of students and staff.

My son will be in first grade at Economy Elementary. The current class size is 74, shared among three teachers. Simple math suggests class sizes of 25, 25, 24. Among the recommendations listed by the CDC are to limit the number of individuals in the classrooms and other spaces; the CDC recommends no more than 25 individuals, including staff. Therefore, we are already out of compliance with such large class sizes.

Additionally, the CDC recommends establishing distances of 6 feet between student desks/seating to the maximum extent feasible and appropriate. Have you recently spent time in an elementary classroom? The classrooms are not designed for social distancing, and, admittedly, this would be challenging in a class of any number. However, limiting the number of students will make some type of distancing possible.

The guidelines make further recommendations for limiting the sharing of materials among students. Among the recommendations are to clean and disinfect shared items between uses, which will be an exorbitant task in a class of 25. Additionally, they

recommend keeping students' belongings separated, which is also logistically challenging since the number of available cubbies is less than the number of students in the classroom, and students tend to share.

The conversation among the community is one of disappointment and continued frustration with the decision-making of the Board of Directors and administration. Many are exploring other schooling options, both for pandemic and personal reasons. The cost to the Ambridge School District to educate a student via cyber or charter school should be considered when making such widespread staffing decisions.

The Board of Directors has a responsibility to provide a safe and productive learning environment for all students. I implore you to reconsider the staffing curtailments and make class sizes reasonable for all.

Finally, I hope the Board of Directors and the administration are preparing for distance learning in the fall, as it is a very real option for schools across Pennsylvania and the country. I hope this includes providing devices to all students in need, the creation of online learning platforms, and the continuance of learning and achievement with as minimal disruption as possible. I recognize the school closures on March 13 were abrupt and unpredictable and our teachers had limited or no training for distance learning

And for the new superintendent when will you have a zoom meet and greet for the community to meet you and you get to understand and care about our concerns/needs or at least act like you care and show enough professionalism to sit up straight and show some respect to the community on the zoom call (it would also help us to understand you clearly, Incase you haven't realized when you speak on zoom it goes in and out).
